    - Stephanie Pessis Weil will lead. In June she will join the joint board meeting for large and small group work
  - Friday Sept 9-Shabbat dinner honoring past and current board members for the past 50 years
  - o Aug BOT meeting-Bob working with the strategic planning committee to present plans in small group work
  - Over the next few months, Bob is developing a governance committee-is the BOT structured/organized in the best way possible? Bob wants this committee to be 5-6 people
  - Executive Director Report-Michael Garlin
    - Sue Lampert presented on Membership Vision and Plans-Susan had worked with Michael on this vision
      - In the last 3 years-213 dropped and 85 new members
      - We need to give members a reason not to quit-need members to have experience with the clergy, staff via in-person, social media, and calls
      - BOT needs to bring in new members-thank you to Hillary Elkins for reaching out to prospective members
      - We need to invite prospective members to events.
      - BOT members should be calling congregants at High Holidays and throughout the year
      - Ideas for clergy-welcome call to all new members within the 1<sup>st</sup> week. Provide new members an Aliyah or Ark opening within the first month, new members shabbat dinners, invite new members to clergy's sukkot, monthly recognition at shabbat services for children's birthdays

- Ideas for Sisterhood-hand delivered welcome bags, personal invitation to opening lunch and sit with a board member, personal invitation to sisterhood shabbat and closing dinner
- Ideas for Men's club-free lox box, personal invitation to opening program, men's club shabbat and closing dinner and sit with board member at the events
- Put pictures and blurb in bulletin, Facebook, Instagram of new members
- Membership committee-develop 1<sup>st</sup> year experience onboarding-welcome email, visit/call from membership committee member, inclusion in Yachad group, assign a mentor family

   The budget is balanced with ~ \$200,000 from reserves. This is a "warning" for years ahead-we can't keep taking from reserves.
